

Memorandum of Understanding

Between:

- a) Polytechnic Institute of Viseu; and
- b) Schneider Electric Portugal, Lda.

Considering:

1. Of all the general objectives of the Polytechnic Institute of Viseu, cooperation with the surrounding community stands out, on a reciprocal basis, aimed at raising awareness of regional problems and implementing adequate solutions. Furthermore, there are other objectives to be taken into account: the technical, humanistic and personal training of its students, in order to enable them to contribute to the development of Portuguese society; training of the region's assets, to further improve the qualification of its workforce and make its human resources more qualified; the development of research activities, based on experience and practice, taking into account the needs of the surrounding context; and the cultural exchange and cooperation with other public and private institutions, nationally and internationally
2. The Polytechnic Institute of Viseu is promoting an initiative that seeks, within the framework of the Recovery and Resilience Plan, to promote collaboration in common activities with Schneider Electric Portugal in a non exclusive basis in the training of youth and adults, in order to prepare the offer of new training programs that respond to the needs of the sector where they develop their activity.
3. Schneider Electric provides training and can provide educational programs to students;

Both parties agree as follows:

I - Through this Memorandum of Understanding (MoU), between the Polytechnic Institute of Viseu and Schneider Electric Portugal, Lda., both parties establish a collaborative relationship and develop cooperation and exchanges in the following areas:

- Industrial automation
- Human machine interface
- Industrial communication
